**NOTICE OF EXPRESSION OF INTEREST FOR PROVISION OF CONSULTANCY SERVICES  
FOR DESIGN REVIEW, DESIGN PREPARATION AND CONSTRUCTION SUPERVISION OF  
INFRASTRUCTURE DEVELOPMENTS UNDER THE COMMUNITY DEVELOPMENT ACTION  
PLAN (CDAP) FOR KARUMA AND ISIMBA HYDROPOWER PROJECTS.**

**PROCUREMENT REFERENCE: UEGCL/CONS/2017/30242**

1. Uganda Electricity Generation Company (UEGCL) together with Ministry of Energy and Mineral Development are to implement the Community Development Action Plan (CDAP) for Isimba and Karuma Hydro Power Project. The purpose of the CDAP is to mitigate increased pressure on local social infrastructure, social services, livelihoods and natural resources, expected to arise from implementation of the two projects at **Karuma in Kiryandongo, Oyam and Nwoya Districts and Isimba in Kamuli, Kayunga and Jinja Districts.**
2. The Government of Uganda has allocated funds towards CDAP implementation in the project affected areas and intends to apply part of the proceeds towards consultancy service for design review, preparation of designs, and construction supervision.
3. The interventions have been packaged in two lots:
  - a. **Lot 1:** CDAP interventions for Karuma Hydro Power Project (infrastructure development)
  - b. **Lot 2:** CDAP interventions for Isimba Hydro Power Project (infrastructure development)
4. The Entity now invites eligible consultants to submit sealed expressions of interest for either of the lots, or both for all the following six categories of interventions:
  - **Water projects:** Borehole repairs, siting, supervision of drilling, design of motorised water supply system including distribution network, review and updates of existing designs (where applicable), preparation of tender documents and provide support to UEGCL during evaluation of bids and supervision of works;
  - **VIP Latrines:** Design of Public and institutional VIP latrines, preparation of tender documents and provide support to UEGCL during evaluation of bids, obtaining approval of building plans from local authorities and supervision of works
  - **Cultural and tourism centre:** Design cultural and tourism centre, preparation of tender documents and provide support to UEGCL during evaluation of bids, obtaining approval for building plan, business plan for tourism and cultural centre and supervision of works
  - **Health infrastructure:** Design of Health infrastructure including wards, staff houses, and renovation of existing structures, preparation of tender documents and provide support to UEGCL during evaluation of bids, obtaining approval of building plans from local authorities and supervision of works
  - **School infrastructure:** Design of School infrastructure, including classroom blocks, staff houses, preparation of tender documents and provide support to UEGCL during evaluation of bids, obtaining approval of building plans from local authorities and supervision of works

- **Electricity grid extension and reticulation network:** Design of grid extension and reticulation network, review of existing designs (where applicable), preparation of tender documents and provide support to UEGCL during evaluation of bids, carrying out construction supervision of proposed grid extensions and last mile connections.
5. Interested consultants should provide information demonstrating that they are eligible and possess the required qualifications to perform the services, supported with relevant documentation.
