ADDENDUM NO.1 EXTENSION OF BID SUBMISSION DATE

1. This addendum follows the Invitation for Bids for the above project that appeared in the United Nations **Development Business** Online Ref. AfDB572-06/17 on 8 June 2017, on the African Development Bank Group's Internet Website on 8th June, 2017, in the New Vision Newspaper on 15th June, 2017 and the East African Newspaper on 17-23 June 2017.
2. The Government of the Republic of Uganda has received a loan from the African Development Bank (AfDB) and African Development Fund (ADF) towards the cost of Multinational Uganda/Rwanda: **Busega – Mpigi and Kagitumba – Kayonza – Rusumo Roads Project**. It is intended that part of the proceeds of the loan will be applied to eligible payments under the contract for the construction of Busega – Mpigi Expressway (23.7Km).
3. The Uganda National Roads Authority (UNRA) now invites sealed Bids from Bidders for the construction up to completion of civil works for Busega – Mpigi Expressway (23.7Km) hereinafter called "the Works". The works will comprise construction of a new four – lane express highway on a new alignment with four grade-separated interchanges, associated drainage and ancillary works as well as implementation of environmental and social mitigation measures.
4. Interested Bidders may obtain further information from and inspect the bidding documents at the offices of the Uganda National Roads Authority at the address in (8) below.
5. A complete set of Bidding documents may be purchased by interested bidders upon submission of a written application to Uganda National Roads Authority, and upon payment of a non-refundable fee of **UGX 370,000 (Ugandan Shillings Three Hundred Seventy Thousand only)** or **US 100 (United States Dollars One Hundred, only)** or its equivalent in a freely convertible currency.
6. The provisions in the Instructions to Bidders and the General Conditions of Contract are the Provisions of the African Development Bank Standard Bidding Document for Procurement of Works.
7. Bids must be delivered to the address in (8) below on or before 11:00 am on **31 August, 2017** and must be accompanied by a Bid Security of **UGX 20,000,000,000 (Uganda Shillings Twenty Billion)** Or **USD 5,500,000 (United States Dollars Five Million Five Hundred Thousand Only)**.
