BID NOTICE UNDER OPEN NATIONAL BIDDING FOR CIVIL WORKS FOR SELECTED INFRASTRUCTURE SUBPROJECTS AND CONSULTANCY SERVICES FOR DESIGN REVIEW AND SUPERVISION OF CIVIL WORKS IN CLUSTER 5, MASAKA CITY AND MUNICIPALITIES OF ENTEBBE AND MUBENDE

- A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application and upon payment of a non-refundable fee of UGX 200,000 (Two hundred thousand Uganda shillings only). The method of payment will be cash deposit to Entebbe Municipal Council General Fund A/c No. 9030005916428 Stanbic Bank, Entebbe Main Branch. After payment, proceed to the Municipal Council Cashier and present the Bank slip to obtain a general receipt which you will then present to the PDU at the address below in No.9 (a), for issue of the bid documents. The document will be obtained from the address stated in 9 (a). No liability will be accepted for loss or late delivery.
- Bids must be delivered to the address below in No.9 (a) at or before **12:00noon, on Wednesday, 2nd December 2020**. All bids for Civil Works must be accompanied with a bid security of UGX 900,000,000 (Nine Hundred Million Uganda Shillings only). Bid securities must be valid until (Monday, 14th June 2021). Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below in No.9 (d) at **12:30.p.m. on Wednesday, 2nd December 2020**. Bids for Consultancy Services must be accompanied by a Bid Securing Declaration.
- There shall be a Pre-bid meeting at 11:00a.m. at the address in No.9(d) on the dates indicated in the proposed schedule in this notice. Bidders are advised to visit sites from the date of this advert.
- Foreign providers shall be required to reserve at least 30% of the value

of works through subcontracting of sub-works and supply of materials, equipment and services to national and resident providers.
