Terms and Conditions

- The evaluation methodologies to be used for evaluation of bids shall be the eligibility and administrative compliance for prequalification, framework contracts, quality and cost based selection (QCBS) for Consultancy services and Technical Compliance Selection (TCS) for works and supplies.
- Interested eligible bidders may obtain further information from Bugweri District Procurement and Disposal Unit and to inspect the bidding Documents at the address P.O. Box 358 Bugweri, between 8:00a.m – 5:00p.m, Monday to Friday.
- The bidding documents in English language may be obtained by interested bidders upon payment of a non – refundable fee of UGX 100,000/=(one hundred thousand only) for each item in **Category A**, 50,000/= (fifty thousand shillings only) for each item in other **Categories**. The method of payments will be by bank (Centenary Bank Account No. 3100056164 Bugweri District Local Government General Fund Collection Account) and Bank slips will be presented to the District Cashier in the Finance Department who will then issue you with the general receipt which must be presented to PDU for issuance of the bidding document.
- Bidders should submit (3) three copies, one marked original and others copies, addressed to the Head Procurement and Disposal Unit, Bugweri District Local Government P.O. Box 358 Bugweri
- The bidding documents shall be delivered to the Procurement and Disposal Unit Bugweri District Local Government P.O. Box 358 Bugweri.
- Deadline for submission is the 26th August, 2020 at 11: 00 a.m. and there after bids will be opened in the District Board room in the Presence of bidders/representatives who choose to attend. Late submission shall be rejected.
