



**Construction of Infrastructure Developments under the Community Development Action Plan (CDAP)
for Isimba Hydropower Projects - Grid extension and electricity reticulation component
in Kayunga and Kamuli Districts**

BID NOTICE UNDER OPEN BIDDING

1. The Uganda Electricity Generation Company Limited has allocated funds to be used for Procurement of Contractors for Construction of Rural Electrification Schemes in Kayunga and Kamuli Districts under the Community Development Action Plan (CDAP) for Isimba Hydropower Projects and intends to apply part of the funds towards payment for the construction works. The details of villages and load centres covered are presented in the statement of requirements.
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to only national and resident providers. In line with the PPDA guideline No. 1/2018 on reservation schemes to promote local content in public procurement, this procurement is reserved exclusively for national and resident providers.
4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8(a) from 9:00 am -5:00 pm during working days.
5. The bidding document which has been prepared in the English language may be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of UGX 200,000. The method of payment will be in the bank on UEGCL A/C No. 9030011177319, Stanbic Bank upon which they shall be presented a bank slip as proof of payment. The document will be picked in person by the bidder.
6. Bids must be delivered to the address below at 8(c) at or before 11:00 am on **3rd September 2020**. All bids must be accompanied by a bid security as detailed below
All bids must be accompanied by a bid security of **UGX 100,000,000**.
Bid securities must be valid until **25th February 2021**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:00am on 3rd September 2020**.
7. There shall be a pre-bid meeting/site visit at Kayunga and Kamuli Project Sites on **12th August 2020** starting at **9:30am**. All bidders shall converge at Busana Sub County Headquarters and will later be guided to various project sites.
