This invitation for prequalification follows the general procurement notice for this project that appeared in *the East African of July 5 - 11, 2014*.

The Government of the Republic of Uganda has received Financing from the Islamic Development Bank (ISDB) towards the cost of implementation of the 132kV Mirama - Kabale Electricity Transmission Line and Distribution Project, and it intends to apply part of the proceeds of this financing to payments for construction of 33kV and 11kV Medium Voltage lines under the contract for:-

The Rural Electrification Agency intends to prequalify contractors and/or firms for detailed engineering design, procurement, construction and commissioning of Medium Voltage (33kV and 11kV) lines, installation of distribution transformers of various capacities (25kVA, 50kVA, 100kVA, 200kVA) and construction of the associated Low Voltage (415V and 214V) lines.

Prequalification will be conducted through prequalification procedures specified in Para 1.7 of the Guidelines for Procurement of Goods and Works under Islamic Development Bank Financing, May 2009 and all bidders are

eligible, except those governed by the Boycott Regulations of the Organization of the Islamic Conference, the League of Arab States and the African Union.
