 - Provide a copy of the Bidder's Certificate of Incorporation or Registration of the firm.
 - ii. Provide a copy of the Bidder's valid Trading licence for 2020 of the firm.
 - iii. Provide a copy of annual income tax clearance certificate for the financial year 2019; OR an original transactional tax clearance certificate specific for this procurement. The original transactional tax clearance certificate should be addressed to Gulu University.
 - iv. Provide a signed letter indicating that the consultant does not have a conflict of interest in the subject of procurement.
 - v. Provide a registered Power of Attorney. For foreign firms, the Power of Attorney shall be notarized.
 - vi. Provide a copy of memorandum and articles of association.

Note: Where the consultant is not registered in Uganda,

the consultant shall submit alternative/ equivalent documents from their country or a statement affirming non-availability of the documents in the country of the consultant.
