1. The Government of Uganda (the Recipient), represented by the Office of the Prime Minister (The Project Executing Agency) received a grant from the Government of the Federal Republic of Germany, represented by German Federal Ministry of Development and Economic Cooperation (BMZ) through KFW, in the amount of **Euro 10 Million** towards the cost of the Refugee Response Fund. RRF is partly implemented by **Save the Children** Germany. Save the Children (the Implementing Agency) intends to apply part of the fund to cover eligible payments for **Constructions in Yumbe District as follows:**

- Save the Children now invites sealed bids from eligible and qualified bidders for Construction of the above works.
- The construction period is: **5 months** from the start date.
- Bidding will be conducted through the National Competitive Bidding (NCB) procedure specified in the KFW Procurement Guidelines (*Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries 2016*), and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
- Interested eligible bidders may obtain further information from Save the Children Uganda and inspect the Bidding Documents at the address given below from 09:00 – 12:00 hours East African Time from Monday to Friday.
- Qualifications requirements include:
 - Minimum average annual construction turnover for the last three years shall be per lot: Ugx 420,000,000 (per lot for lots 1, 2, 7, 8, 9); Ugx 600,000,000 (For lot 3); Ugx. 220,000,000 (per lot for lots 4, 6, 10) and Ugx. 450,000,000 (for lot 5).
 - The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments for the amount as below (evidence shall consist of equivalent balances in bank statements, or unconditional bank loan offer specific to this tender):
Per lot, for lots 1, 2, 7, 8, 9: Ugx 55,000,000; For lot 3: Ugx. 80,000,000; Per lot, for lots 4, 5, 10: Ugx. 25,000,000 and For lot 6: Ugx. 60,000,000.
 - Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years (Since Jan 01st 2017), with a value given below for respective lots, that have been successfully and substantially completed and that are similar to the proposed Works (evidence shall be completion certificate or letter from client)

8. Bids must be delivered and received in hard copies, sealed and dropped in tender box at the address below on or before 14th January 2021, 10:30 Hours East Africa Time. Late bids will be rejected. Bids shall be opened immediately after bid submission deadline, in the presence of the bidders or the bidders' representatives who choose to attend electronically via a video conferencing link which shall be shared prior submission deadline.
