The Government of Uganda has received financing from the African Development Bank towards the Water Supply and Sanitation Programme-Phase II and intends to use part of the loan to pay for consultancy services for Construction supervision of 30 solar powered mini-piped water schemes and technical planning, design and construction supervision of additional 40 solar-powered schemes in rural areas including community mobilization, sanitation and hygiene improvements.

The overall scope of the assignment is to assist MWE in all activities of the implementation of 70 solar powered mini-piped water schemes on selected boreholes. **Component A** includes construction supervision of 30 solar powered mini-piped water schemes while **Component B** consists of technical planning, design, procurement and construction supervision of 40 solar powered mini-piped water schemes. **Component C** of the assignment involves community mobilisation, training and institutional support for all the 70 borehole sites.

The services shall be required for a period of approximately 48 calendar months inclusive of a 12 months low intensity period of monitoring correction of defects.

The Ministry of Water and Environment now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (profiles, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's ***"Rules and Procedures for the Use of Consultants" May 2008 Edition***, Revised July 2012 which is available on the Bank's website at <http://www.afdb.org>. The Borrower is under no obligation to shortlist any Consultant who expresses interest.
