The **Kampala Capital City Authority** received financing from the World Bank towards the cost of the Second **Kampala Institutional and Infrastructure Development Project** and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include provision of design review and construction supervision services for drainage improvement works as below

Where drainage channels cross existing roads, it will be necessary to reinstate roads (at the channel crossing) to the same levels, dimensions and structural strength as before the works. Existing foot bridges will be rehabilitated and new pedestrian channel crossings will be installed at designated locations. Selected right-of-way sections of the rehabilitated channels will be landscaped to KCCA's specifications.

**Kampala Capital City Authority** now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services including brochures, organizational set up. **The short listing criteria will be as follows:**

- 1) General experience of the firm in at least 10 infrastructure engineering studies and;
- 2) Experience of the firm in planning, design and supervision of infrastructure projects in the African tropic regions on at least 5 projects
- 3) Relevant experience of the firm on at least 3 assignments of similar type, nature and scope;
- 4) Availability of appropriate skills/expertise among the consultant's staff including engineering project management and documentation, hydrology/drainage engineers, materials engineers, engineering surveyors, structural engineers, measurement engineers, architects, claims experts and social and environmental experts. Individual experts' bio-data is not required.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants [under IBRD Loans*

*and IDA Credits & Grants] by World Bank Borrowers January 2011* ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. The type of association whether a joint venture or a sub-consultancy, where applicable, **must** be clearly indicated in the Expression of Interest.

A Consultant will be selected in accordance with the with the **Quality and Cost Based Selection (QCBS)** method set out in the Consultant Guidelines.
