## BID NOTICE UNDER OPEN DOMESTIC BIDDING

### PROPOSED CONSTRUCTION OF LABORATORIES, MDR TREATMENT AND ISOLATION UNITS (MOROTO, ENTEBBE AND MULAGO. [Procurement No: MoH-EAPHLNP/WRKS/2017-18/00008/004-006]

1. The Government of Uganda has received a loan from the World Bank to fund the Proposed Construction of Laboratories, MDR Treatment and Isolation Units. Ministry of Health under the EAPHLNP has earmarked three (03) to be remodelled.
2. The Ministry of Health now invites sealed bids from eligible bidders for Proposed Construction of Laboratories, MDR Treatment and Isolation Units listed in as **Lot 01, Lot 02 and Lot 03 (hereinafter referred to as "the works")**
3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Government of Uganda Public Procurement and Disposal of Public Assets Act, 2016, and is open to all bidders from Uganda.
4. Interested eligible bidders may obtain further information from the Ministry of Health Headquarters at the Procurement and Disposal Units, inspection of the bidding documents will be from **0800hrs to 1700 hours effective 10th January 2019.**
5. A complete set of Bidding Documents in English may be purchased by interested bidders on submission of a written application to Head of Procurement and Disposal Unit of Ministry of Health Head Quarters upon payment of a non-refundable fee of **UgShs.100, 000 (Uganda Shillings One Hundred Thousand Only)** effective 10th November 2019.  
The method of payment will be through Ugandan Bank authorised to receive non-taxable revenue (on Account No. 000140168000001 – Account title: Health – NTR).
6. Bids must be delivered to the Office of Head PDU Ministry of Health at the Headquarters on or before **20th February 2019, 10:00a.m.** Bids will be opened immediately thereafter in the presence of the bidders' representatives who choose to attend at the Procurement and Disposal Units premise at 10:30a.m. All bids must be accompanied by a bid security of **Ush. 50,000,000 for Lot 01, Ush. 100,000,000 for Lot 02 and 150,000,000 for Lot 03).** The bid security will be in form of a Bank Guarantee obtained from a reputable commercial bank subject to verification and late bids shall be rejected.
