FINAL COMPENSATION OF PROJECT AFFECTED PERSONS (PAPs)

The Rural Electrification Agency (REA) under the World Bank funding constructed distribution lines in the project areas of Kiganda-Mile 16 with Tee off to Katabalanga and Kibyamirizi (Mubende District) and Ruhumba-Kashwa with Tee off to Rwebishuri (Mbarara and Kiruhura Districts) in 2019/2020.

Resettlement Action Plans (RAPs) were prepared for the two projects to establish the associated social impacts and their mitigation measures including clearance of wayleaves and compensation to the PAPs for their damaged properties. These were publically displayed in the national dailies and on the World Bank website.

Following the several compensation exercises carried out along the different project areas, we have some persons who remain unpaid. Efforts to locate them in the past have proved futile.

Please note that this is the final compensation exercise for the project. It will be assumed that whoever will not have claimed their payment by December 31st 2020 will not be interested in payment and the fund will be reverted to the Government coffers.
