4. Eligible Bidders must have:
 - Registration/Certificate of Incorporation, income Tax Clearance, VAT registration Certificate, 2020 Trading License
 - Company Profile with clear memorandum and articles of association and clear company management set up
 - Evidence of relevant Experience in executing similar works
 - Financial/ audited books of accounts for the last three years.
5. Qualified and interested bidders should submit sealed envelopes to URCS Offices on plot 551/555 Rubaga Road Supply Chain Management Office within the period indicated above.
6. **Bid submission mode:** One envelope submission method system will be used where the bidders are expected to submit one envelope (technical Combined with Financial)
