1. The Uganda Electricity Distribution Company Limited has allocated funds for supply of seasoned wood poles under a framework contract for two years.
 2. The Entity invites sealed bids from eligible bidders for supply of the above supplies.
 3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

The method of payment will be by depositing money on UEDCL bank account and presentation of a banking slip.
